Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 24 as per the number of sections reported during inspection, of which not more than 1/3rd sections may be used for senior secondary classes. Number of the students shall be restricted to 32 in 17 sections (as pre dimension reported during IC). Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of greater than 500 ft dimension.
